Customers can check the Corporate Total Asset Balance through the Corporate Internet Banking platform or by visiting the nearest branch of the Bank.

- (2) 貸款: 往來賬戶、押匯賬戶及貸款賬戶已使用授信額 Loans: utilized credit limits of current accounts, bill accounts, and loan accounts
- (3) 投資: 債券、基金、結構性產品【股票掛鉤投資/外幣掛鉤存款/外幣掛鉤投資】的市值 Value of investment assets: bonds, investment funds, structured product 【equity linked investments/currency linked deposit/currency linked investment】
- (4) 保險: 香港人壽人壽保險之保單價值 Policy value of life insurance plan of Hong Kong Life
